## 4-H Meeting Guidance and Best Practices

All youth participating in this Virtual Showcase must follow NYSDOH guidelines. The number of people in attendance of any meeting may not exceed the number permitted by the phase of reopening for your region. The number includes total of leaders, members, parents, speakers, etc. Attendance should be taken for accountability and documentation of meeting size.

Social distancing procedures include the following Best Practices:

- The wearing of masks by all participants OR
- Maintaining 6-foot distances between participants without touching of any kind
- Hold meetings outdoors whenever possible, or in a public or CCE space. Meetings should not take place in private homes.
- Hand sanitizer should be available at all times.
- The meeting time should be limited to no more than 1.5 hours
- Only single-serve, commercially prepped, food and drink should be provided. Participants are welcome to bring their own water (clearly labeled with their name) for hydration.

There will be youth and families who are not comfortable meeting in person at this time. It is critical that these decisions are respected and that there is no pressure applied, or opportunities withheld, due to a decision not to participate.

- **In addition to following the NYSDOH guidelines, all participants must submit a signed “Volunteer Assumption of Risk Form” found on page 12 of this document.**
- **All participants pictured in a photo or video must submit the 4-H Photo Release Form found on page 13 of this document. This includes the Cloverbud parent/guardian who plans to be in an Animal Project photo.**

This Virtual Showcase will be posted online through the Schoharie County 4-H webpage and through the Schoharie County 4-H Facebook page. Please contact your local 4-H office if you have any questions or concerns.

## **4-H Cloverbud General Rules and Regulations**

4-H Cloverbuds, the youngest participants in the 4-H Club Program, are enthusiastic, curious, creative, robust, and resilient young people who are growing physically, cognitively, socially, and emotionally through a period of rapid and often uneven development. The 4-H Cloverbud Program has been designed to meet the very special needs of these 5 to 8-year olds. The New York State Cloverbud Policy specifies a Cloverbud must turn 5 by January 1 of the 4-H club year and must have been enrolled in Kindergarten at the beginning of the school year.

**Safety** – Safety is always a concern in any program that involves youth. It is of particular importance when working with 4-H Cloverbuds (children develop mentally in the kindergarten to third grade level.) When working with this audience and animals, it must be remembered that the safety of the youth is the primary concern and objective. The developmental levels of 4-H Cloverbuds may limit their ability to work safely in some project areas. Care must be taken not just with animals, but also with any 4-H Club activity that may include animals, large equipment, certain outdoor activities (games and athletic activities, water activities, etc.) or other situations where safety of youth would be an issue.

**Recognition** – For 4-H Cloverbuds, recognition should be informal and equal for all participants. Recognition of all 4-H members in the Virtual Showcase (including Cloverbuds) will be the same. The Virtual Showcase will not be judged, and all exhibitors will be equally recognized for each of their accomplishments.

This Virtual Showcase is meant to show off 4-H projects that have enhanced the knowledge and skills, as well have encouraged personal development of the members over the course of the year. It is important that during these times, we can support the growth of our youth.

### **Cloverbud Participation**

- Each 4-H Club Organizational Leader in cooperation with the 4-H Cloverbud member's parents or guardians should decide whether or not this showcase is an appropriate level of participation for the individual 4-H Cloverbud.
- All Cloverbuds are welcome to participate in the Non-Animal Project and Animal Project sections as long as activities comply with *NYS Cloverbud Policies*, the *NYS 4-H Animal Science Cloverbud Policy*, and the specific animal policies outlined in this document.
- 4-H Cloverbuds will not be allowed to participate in the Animal Showmanship section.



## SECTION 1

# *Non-Animal Projects*

1. Please read all rules/requirements before submitting your non-animal project entry.
2. Items that would have been eligible at the 2020 Schoharie County Fair are eligible to be in the Virtual Showcase.
3. **A maximum of three non-animal projects** can be submitted per 4-H member.
4. **Projects will be submitted by photo.** Projects must be photographed with an appropriate backdrop and close up so item details can be seen. 4-H members can choose to be in the picture with their project.
5. One photo should be submitted of each project, along with a short (40 word max) description. The description should include the member's name and what the project is, and may choose to include his/her favorite part about working on the project or what the member learned from the project this year.

**Project registration is open until further notice.** Photos and descriptions should be submitted through the registration link above.
7. If you have a barrier preventing you from taking/submitting the photo, please contact your local 4-H Educator, and we will schedule a time to come and take the photo.
8. **Projects will not be judged in this virtual event**, rather, they will be showcased to the public to show off the hard work of our 4-H members this year.
9. This section is open to enrolled Schoharie County 4-H members. 4-H Cloverbud members are invited to exhibit entries of items done as a result of the Cloverbud project book, or any other appropriate item in the area of foods, clothing, art objects, crafts, photography, scrapbooks, woodworking, natural resources, and gardening items. All Cloverbud 4-H activities need to comply with the *New York State 4-H Cloverbud Policies*. All projects must also follow NYS 4-H guidelines and safety precautions described within each project category.
10. It is expected that all exhibitors act in an appropriate manner. Any member found conducting themselves in an improper manner or who violates any of the rules as set forth will be dismissed from the showcase.

## SECTION 2



# *Animal Projects*

1. Please read all rules/requirements before completing your animal project entry.
  2. Animal projects that would have been eligible at the 2020 Schoharie County Fair are eligible to be in this Virtual Showcase.
  3. **A maximum of three animal projects** can be submitted per 4-H member.
  4. **Projects will be submitted by photo.** The 4-H member should be photographed with their animal project in front of an appropriate background. All animals should look appropriate for the showcase photo.
  5. One photo should be submitted for each project, along with a short (40 word max) description. The description should include the name of the animal, breed of animal, and age of animal. The member may also choose to include his/her favorite part about working with the project animal or what they learned from the project this year.

- Project registration is open until further notice.** Photos and descriptions should be submitted through the registration link above.
7. If you have a barrier preventing you from taking/submitting the photo, please contact your local 4-H Educator, and we will schedule a time to come and take the photo.
  8. **Animal projects will not be judged in this virtual event,** rather, they will be showcased to the public to show off the hard work of our 4-H members this year. Exhibiting 4-H projects provides opportunities for youth recognition as well as learning experiences.
  9. This section is open to enrolled Schoharie County 4-H members. 4-H Cloverbud members are invited to exhibit entries of animal projects as long as all 4-H animal activities comply with the *NYS Cloverbud Policies* and the *NYS 4-H Animal Science Cloverbud Policy*. Please contact your county 4-H Educator if you need a copy of the Cloverbud Policies.
    - o Note: 4-H Cloverbuds must have worked with the animal during the current 4-H Club year. The 4-H Cloverbud must be able to control the animal: halter is recommended where appropriate. Any Cloverbud animal activity must be

done in a controlled environment, contained ring, and take place in a safe contained/fenced in area and under the supervision of their parent/guardian. All Cloverbud member animal project photos must include the parent/guardian in the photo as well.

10. If the animal you are using as your 4-H project is not owned by your family, you must submit a lease agreement. Please contact your local 4-H educator for details.
11. All 4-H members are required to wear proper footwear when working with animals and in animal barns. Sneakers or barn boots are strongly suggested.
12. All 4-H members who plan on submitting a photo of a 4-H dog project, must follow the policies found in the *New York State 4-H Dog Policy*.
13. All 4-H members who plan on submitting a photo of a 4-H horse project, must follow the safety policies found in the *New York State 4-H Equine Show Rule Book*. Please contact your county 4-H Educator if you need a copy of this policy.
  - Helmet Policy: All youth participating in this official 4-H event, shall wear a properly fitted and secured, officially approved ASTM/SEI protective helmet at all times when leading and handling an equine. Failure to comply with this rule will result in dismissal from the Virtual Showcase. Note: Mounted equine activities are not a part of this Virtual Showcase.
14. It is expected that all exhibitors act in an appropriate manner. Any member found conducting themselves in an improper manner or who violates any of the rules as set forth will be dismissed from the showcase.

### SECTION 3



# *Animal Showmanship*

1. Please read all rules/requirements before completing your animal showmanship entry.
2. An Animal Showmanship entry that would have been eligible at the 2020 Schoharie County Fair is eligible to be in this Virtual Showcase.
3. **A 4-H member may submit one animal showmanship video (per species)** to display in the Virtual Showcase.
4. **Showmanship will be submitted by video.** An exhibitor should prepare to show the animal's best attributes as they would in the show ring. The 4-H member should be filmed with their animal project in front of an appropriate backdrop. All animals should be prepped appropriately for the showcase video.
5. Each video submission should include a short (40-word max) written description. The description should include the name of the animal, breed of animal, age of animal, how many years the member has been in showmanship, and may choose to include the animal's best traits, future plans with the animal, etc.
6. Showmanship entries should be registered through the following link:

**Showmanship registration is open until further notice.** Videos and descriptions should be submitted through the registration link above.
7. If you have a barrier preventing you from taking/submitting the video, please contact your local 4-H Educator and we will schedule a time to come take the video.
8. **Showmanship will not be judged in this virtual event**, rather, members will be showcased to the public to show off skills gained throughout the year. Displaying showmanship skills provides opportunities for youth recognition as well as learning experiences.
9. **Each animal showmanship video should be under 90 seconds.** The video does not have to be complex; it can simply be recorded using a cell phone.

Please view the sample videos on the following page, to get an idea of what your showmanship video should contain.

Note: Your video should contain general showmanship practices for your species/breed. The below sample videos are guidelines for what your showmanship video could look like.



- **Livestock (Dairy, Beef, Sheep, Swine, Meat/Dairy Goat)**  
Video of member and animal should include side view, front and rear views, and 'On the Move' from the side, rear, and front.

- **Dogs**  
Video of member and dog in stack from the front, rear, and side. View of dog gaiting from the side, coming and going back. Display teeth (show front and sides).

- **Rabbits**  
Video of member posing the rabbit properly for the breed. Check the ears, eyes, teeth, nose, fur condition, feet and nails, gender. (Note: Virtual Showcase videos will not have audio. Members do not need to verbally explain what they are doing throughout the video.)

- **Poultry**  
Video of member showing animal's head and eyes, gently fan out the wing of each side, show body width, check feathers, show breastbone, legs, feet, and toes. Finally pose your animal according to breed standard. (Note: Virtual Showcase videos will not have audio. Members do not need to verbally explain what they are doing throughout the video.)

- **Equine (Showmanship at Halter)**  
Video of member and animal should include setup of your horse with side view, front and rear views. 'On the Move' at the walk and/or trot with a halt and set up (in no particular pattern).

10. This section is open to enrolled Schoharie County 4-H members. 4-H Cloverbuds will not be allowed to participate in the Animal Showmanship section.
11. If the animal you are using as your 4-H project is not owned by your family, you must submit a lease agreement. Please contact your local 4-H educator for details.
12. All 4-H members are required to wear proper footwear when working with animals and in animal barns. Sneakers or barn boots are strongly suggested.
15. All 4-H members who plan on submitting a dog showmanship video, must follow the policies found in the *New York State 4-H Dog Policy*. Please contact your county 4-H Educator if you need a copy of this policy.
16. All 4-H members who plan on submitting a horse showmanship video, must follow the safety policies found in the *New York State 4-H Equine Show Rule Book*. Please contact your county 4-H Educator if you need a copy of this policy.
  - **Helmet Policy:** All youth participating in this official 4-H event, shall wear a properly fitted and secured, officially approved ASTM/SEI protective helmet at all times when leading and handling an equine. Failure to comply with this rule will result in dismissal from the Virtual Showcase. Note: Mounted equine activities are not a part of this Virtual Showcase.
17. It is expected that all exhibitors act in an appropriate manner. Any member found conducting themselves in an improper manner or who violates any of the rules as set forth will be dismissed from the showcase.

**4-H Meeting Guidance and Best Practices**  
**June 2020**

The purpose of this document is to support local discussion and decision making regarding 4-H programming, club meetings and other programs during the upcoming period of gradual re-opening.

4-H activities that fall with Agriculture exhibits and training have already been specifically mentioned at the State level as [allowable in phase one](#).

Organizers conducting these types of activities must, per the NYSDOH:

1. Comply with all NY Forward, Phase One "[Non-food Related Agriculture Summary Guidelines](#)".
2. Read and affirm the detailed guidelines for non-food agriculture.
3. Develop and implement a safety plan.

In addition to following the NYSDOH guidelines **all participants** must sign the "[Volunteer Assumption of Risk Form](#)" shared with CCE Association Executive Directors on June 10, 2020.

### 4-H Group Meeting Best Practices

1. Designate a CCE Educator who will be responsible for sharing these best practices with volunteers who will be allowed to hold CCE meetings to ensure that proper procedures are being followed.
2. The number of people in attendance of any meeting may not exceed the number permitted by the phase of reopening for your region. (ie. Phase 3 should be no more than 25 people at a meeting) The number includes total of leaders, members, parents, speakers, etc. Attendance should be taken for accountability and documentation of meeting size.
3. Social distancing procedures include the following Best Practices:
  - The wearing of masks by all participants **OR**
  - Maintaining 6-foot distances between participants without touching of any kind
  - Hold meetings outdoors whenever possible, or in a public or CCE space. Meetings should not take place in private homes.
  - Hand sanitizer should be available at all times.
  - The meeting time should be limited to no more than 1.5 hours.
  - Only single serve, commercially prepared, food and drink should be provided. Participants are welcome to bring their own water (clearly labeled with their name) for hydration.

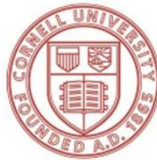
